# MINUTES OF THE PARISH COUNCIL MEETING Tuesday 11<sup>th</sup> April 2023 8.00pm in the Village Hall

## **40.23 DECLARATIONS OF INTEREST**

Councillors Symonds and Martin declared an interest in item 48.23 as trustees of the Poor Piece and Clocklands Charity.

## 41.23 MINUTES OF THE PREVIOUS MEETING

The minutes of the Parish Council Meeting held on 14<sup>th</sup> March 2023 were approved and signed.

#### 42.23 BUCKINGHAMSHIRE COUNCIL

Councillor Phil Gomm, Buckinghamshire Council Councillor, gave an update on the following:

- (a) The recent roadworks along Marstonfields were official Highways works. Two cattle grids are being decommissioned. Highways are liaising with the farmer, Neil Tuckett.
- (b) The new Highways contractors, Balfour Beatty, have spent time speaking to Buckinghamshire Council Highways staff about operations and priorities and are now ready to move forward with Highways projects.
- (c) Councillor Gomm is aware of the two new potholes in Church Street and the one along Marstonfields. He is dealing directly with Highways about these to get them repaired using the appropriate machinery for the job.
- (d) The next Community Board meeting is schedules for 25<sup>th</sup> April 7.30-9.00pm in the St Laurence Room, Winslow. Applications for funding from community groups are encouraged. There is £103k in the budget to distribute this year.
- (e) The kerbing installed on School Hill is not in keeping with the Conservation Area and Councillor Gomm has asked the Parish Council to allow him to deal directly with Highways about this.
- (f) There have been further reports of boom box music being played very loudly late at night and into the early morning by young people from North Marston and Granborough villages. Parents are being consulted to try to find an amicable and helpful solution.

#### 43.23 PLANNING APPLICATIONS

- (a) There have been no planning applications received since the last meeting.
- (b) Correspondence from a resident regarding an alleged breach of Planning and reported to Enforcement was acknowledged. The Parish Council has no powers in Enforcement matters and has no comment to make unless officially asked to do so by Enforcement.
- **44.23 PLANNING FOR THE CORONATION EVENT:** The event co-ordinator gave a brief update and reported that all plans are progressing well.

#### **45.23 ENVIRONMENT**

## 1a. Highways

The School Hill kerbing stones had already been discussed under Councillor Gomm's update. There were no updates on the Highways items apart from requesting that the Clerk remove (ii) from the list as the drain has been repaired. The three new potholes in Church Street and Marstonfields were again highlighted. The current list of remedial work to be carried out is as follows:

- (i) School Hill Kerbing Project kerbing stones used.
- (ii) 040184085: drain near kerb of 47, High Street reported as dangerous
- (iii) 49 Portway: drain marked up for further work.
- (iv) 40202701: Poor state of pavement between 27 & 37 Quainton Road
- (v) 40207528 Road subsidence on Portway near field gate (Marston Hill end of village)
- (vi) 40221096 Pothole in centre of road in Church Street
- (vii) 40222510 1 metre square pothole outside of No.4 Church Street
- (viii) 4391939 1-metre square and deep pothole in Marstonfields 100 yards after first cattle grid.
- **2. Street lighting:** The new two-year contract with SSE is due to start on 1<sup>st</sup> June 2023, saving over £3k on the price quoted by nPower. A rebate of £1,028.00 is due to the Parish Council as it has been overcharged since the changes to LED lighting. This will reduce slightly as the charges for streetlighting in March/April and May have still to be charged and will be taken from the credit amount.

#### **46.23 THE SHOP**

- (i) A green grit/salt bin has been ordered to serve the Village Hall/Shop car park.
- (ii) Subsidence at Village Hall/The Shop car park:

It was suggested that there should be a discussion around making provision for any future repairs needed to the car park and about some form of shared responsibility with The Shop for this. Councillor Gomm suggested that Community Board funding may be available for the project on this occasion and encouraged the Clerk to submit an application once the costs are known.

**RESOLVED:** The Clerk to obtain quotes for the remedial work necessary to the Village Hall/Shop car park. Councillor Boyt agreed to send the Clerk the names of possible contractors who could be approached.

## **47.23 PARISH ACTION PLAN & PROJECTS**

## The following updates were received:

- 1. Village Hall
- (i) The Clerk advised that the new folding chairs, trolleys and two new 6ft Gopak folding tables have been delivered to the hall. The chairs are padded and very comfortable.
- (ii) The exterior back wall light to the Village Hall appears not to be working.

**RESOLVED:** The Clerk to obtain a quotation from Ian Carnell Electrical for the repair of the exterior sensor light. (UPDATE: upon leaving the hall the light **did** appear to be working so further investigation required)

- (iii) The Chairman has prepared a final specification for audio-visual equipment and will send that to the companies who have already quoted.
- 2. Threshing Barn inclement weather has so far prevented the patching of the roof being carried out by Alder Roofing.

- 3. Village and Parsnip Pond the overgrown vegetation and dead trees around Parsnip Pond were recently cleared by a group of local volunteers and the new pond habitat info graphic has now been installed at the village pond.
- 4. Aylesbury Wild Vale Project no updates
- 5. Play Area no updates
- 6. Sports field the steps down to the field have been extended for safety reasons and a new concrete ramp has been installed at the brick store to make ground maintenance equipment more easily accessible.

#### **48.23 POOR PIECE & CLOCKLANDS**

Correspondence had been received from the Reverend Petra Elsmore requesting that the Parish Council verify the appointment of Peter York as a trustee. This would be to fill a casual vacancy for the unexpired term of the appointee's predecessor which comes to an end in September this year. As Councillors Martin and Symonds declared an interest as trustees of the charity, there was not the required minimum three councillors to vote on the matter.

**RESOLVED:** That the Parish Council vote on the appointment at the May AGM meeting.

#### **49.23 FINANCE**

(a) The receipt of the Parish Devolution payment from Buckinghamshire Council of £2,073.74 was acknowledged.

**RESOLVED:** The Clerk to liaise with Councillor Gomm to ensure that the Parish Council is receiving the correct amount in accordance with the services devolved to the parish.

- (b) **RESOLVED:** The Asset Register was approved for the forthcoming 2022/23 internal and external audits.
- (c) The Parish Council considered the three applications for funding from its small grants scheme for 2023/24. £950.00 is available to distribute.

**RESOLVED:** That 1<sup>st</sup> Granborough Scouts to receive funding of £400 towards the costs of camping equipment. The EEC and North Marston C of E School each respectively receive £275.00 towards the costs of new hymn books and colourful playground signage promoting good manners and positive values. Funding to be released upon the receipt of invoices for the purchases.
